The Jindalee Golf Club was opened in 1967 to provide golfing facilities and a social venue for the residents of the Centenary Suburbs in particular and the community in general.

All categories of Membership of the club as outlined in the Club's Constitution are by application and subject to approval by the Jindalee Golf Club Executive Committee. Once approved this membership carries certain responsibilities that must be observed by everyone.

Therefore, members need to observe the following:

- To treat fellow members, guests and workers of the club with respect and courtesy irrespective of gender, race, religious affiliation or political views
- To always conduct oneself in a proper manner
- To not be intrusive of others
- To dress neatly and in accordance with the general rules of dress laid down by the Club
- To respect the facilities of the Club
- To display the highest personal standards and expect no less from others
- To support the objectives of the club and provide personal assistance if required and able to help
- To enjoy and allow others to enjoy all that membership of the Club provides
- To support and assist the current Executive Committee of the Club and Club staff in their efforts to manage the club on your behalf
- To abide by the rules and by-laws in force from time to time and agreed by you when making your membership application.
- To comply with Australian and Queensland law.

The Jindalee Golf Club Incorporated as a provider of alcohol and gaming facilities has social, legal and safety responsibilities to its members, visitors, and community in general, and for that purpose this code was developed some years ago and revised again in 2025.
